Traffic Accident

Contempt of Court

~On 2/14/2026 at 19:27 hrs., Officer was on patrol on 9th st. and observed a vehicle parked in the driveway on 9th St. Officer knows from prior professional contacts, that this vehicle is owned and driven by a 57-year old Windom male that has a pending criminal case of malicious punishment of a child. Officer checked the most recent release order issued by the court with one of the conditions was that the Windom male was prohibited from being at this address on 9th St unless accompanied by LE one time to gather belongings.

After investigation, a 57-year old Windom male was arrested for Contempt of Court.
