

Jackson County Sheriff's Office Report August 24th to August 31st

8-24 Monday

8:00 AM A deputy transported a 29 year old male from Jackson from the Steele County Jail back to the Jackson County Jail on a Jackson County warrant for Probation Violation - Felony Domestic Abuse No Contact Order.

Two wind tower employees located an abandoned vehicle concealed behind a wind tower they were going to work on. The vehicle had both license plates missing, and they noticed the VIN number on the dash had been defaced. They drove away from the area for safety reasons and called 911 to report it. As they were leaving the area, they observed a person walking down the same windmill access road a couple hundred yards away wearing dark clothing and a dark colored backpack. When this person noticed their construction truck, they jumped into the cornfield and disappeared. Deputies were able to find VIN numbers in other areas of the vehicle. They discovered the same vehicle was involved in a pursuit involving several neighboring law enforcement agencies the night before. During the pursuit, the suspect drove at extremely high speeds and was ultimately able to evade law enforcement. They were also able to identify the driver as a 40 year old female from Wisconsin.

Law enforcement established a perimeter and conducted an extensive search using K-9s and drones, but she has not been located. Assisting agencies included the Martin County K-9 Unit and deputies, the Worthington PD K-9 Unit, the Windom PD, the Cottonwood County SO, and the MN State Patrol.
